THANJAVUR – 613005 and THANJAVUR INSURANCE, INSTITUTE , GANDHIJI ROARD , SHIVAJI NAGAR , THANJAVUR – 613001 are authorized by state law to establish and enter into agreements for dual credit programs . This MOU will be carried out within the framework of the respective laws and regulation laws and regulation of the two institutions and is not intended to create any legally binding rights or obligation.
