MEMORANDUM OF UNDERSTANDING

The Memorandum of Understanding is made and entered into on 13 March 2019 between the PG and Research Department of Commerce, Bharath College of Science and Management, Bharath Avenue, Thanjavur -613005 and Indian institute of Catering Technology and Hotel Management, Thanjavur District – 613504 .

1. PURPOSE :

The purpose of this Agreement is to define the basis for collaboration between the parties in Training concerning; Membership in Board of Studies, Curriculum Development.

2. SCOPE OF THE MOU:

1. The said members of the board of Studies will also after his/her Expertise in the development of the curriculum to be offered in line with requirements of the industry so that the students will be skilfully and gainfully employed on completion of the programme.
2. Student will be involved in Event Management Coordination of the programme, which includes, public Relations management.
3. Experience Certificate will be issued After the Event which will be signed by Coordinate of both parties.

3. ENTRY IN TO EFFECT AND TERMINATION:

1. This MOU shall be valid for a period of three years from effective date. Thereafter the parties may mutually agree to extend this MOU in writing.
2. Either party may terminate this MOU for convenience with thirty days prior written notice to the other party.
3. Parties may terminate this MOU upon giving a thirty days written notice to the other party for breach of any material provision of this MOU , and where there is failure to correct such breach within the said notice period .

4. OTHER GENERAL TERMS:

1. It is agreed between the parties that this is an arrangement between principal to principal and both the parties shall not represent to third parties that they are the agent of the other. Nothing in this MOU shall be construed to grant either party the right make commitment of any kind for or on behalf of the other party without prior written consent of the other party .
2. This MOU contains no representations or warranties and the parties specifically disclaim any and all warranties , express or implied , with regard to this MOU and subject matter hereof.

5. CONFIDENTIALITY AND IPR:

All commercial, process, product and design information specific to the organisation, shall be kept confidential, publication of any results in public domain shall only be after mutual written consent. Intellectual property rights arising from joint collaborative work shall be shared mutually based on prior agreement for specific projects.

This MOU shall be governed and construed in accordance with the law of republic of India. Dispute, if any, arising out this MOU will be mutually discussed and settled without any obligation on either party failing with the disputes . who shall act as 'Presiding Arbitrator' The Arbitration proceedings shall be in accordance with the provisions of Arbitration and conciliation Act ,1996 and rules framed there under from time. The place of Arbitration shall be at Trichy and all Arbitration proceeding shall be conducted in English language and governed by the above said Act and Rules and in Indian laws.


