#### **SCOPE OF CO-OPERATION**

- (1) Offering classes to the students for their development in skills through direct and student exchange programme for classes in a period of 15 days.
- (2) Encouraging involvement of final year students to take up projects.
- (3) Providing Entrepreneur Development Program to the students.
- (4) Providing practical skill.
- (5) Providing marketing information to the students.

#### **IMPLEMENTATION AND FUNDING**

- (1) The sides will establish a joint committee for policy dialogue to regularly exchange information and experience on education challenges and reform, and identify priorities for bilateral co- operation in the field of Entrepreneur

#### **AMENDMENT**

- (1) This MOU may be made amendment by mutual written consent of the sides.

#### **ENTRY INTO EFFECT AND TERMINATION**

- (2) This MOU will remain in effect for a period of 3 years unless either side notifies the other side, in writing, of its intention to terminate this MOU at least Six months before the expiry date of the relevant period;
