WHEREAS ,DEPARTMENT OF COMMERCE , BHARATH COLLEGE OF SCIENCE AND MANAGEMENT , BHARATHI AVENUE ,

THANJAVUR – 613005 and THANJAVUR INSURANCE, INSTITUTE , GANDHII BOARD , SHIVAJI NAGAR , THANJAVUR – 613001 are authorized by state law to establish and enter into agreements for dual credit programs . This MOU will be carried out within the framework of the respective laws and regulation laws and regulation of the two institutions and is not intended to create any legally binding rights or obligation.

SCOPE OF CO-OPERATION

- (1) Exchange of information on research , teaching ,learning and other literature relevant to educational and research programmes;
- (2) Offering classes to the students for their development in skills and intelligence through direct and student exchange programme for classes in a period of one week;
- (3) Encouraging involvement of final year students to take up projects of the industry and build up professional confidence and competence ;
- (4) Providing training and placement opportunity to the students
- (5) Providing practical skill and tests;
- (6) Join organization of seminar, conferences, and workshop.

IMPLEMENTATION AND FUNDING

- (1) The sides will establish a joint committee for policy dialogue to regularly exchange information and experience on education challenges and reform, and identify priorities for bilateral co- operation in the field of education.
