MEMORANDUM OF UNDERSTANDING

This deed of Memorandum of Understanding (MOU) is entered between Thai Institute of Carving having registered office at 1560, Pagandai Main road, Kozhipakkam, Cuddalore district - 607 112 with focus on creating carving chefs, training academically and having expertise in carving techniques, hereinafter referred as 'INDUSTRY'.

AND

Bharath college of science and management - an institution with focus on imparting education with high reputation for its academic standards and commitment, having their campus at Near new bustand, Thanjavur- 613005 herein referred as 'COLLEGE'.

NOW IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO:

PREAMBLE

Industry – Institutional collaboration Initiatives will lead to efficient complementation of resources of both the sponsors eventually leading to the development of a house of excellence for quality training, research and development which will be of immense mutual benefit and also relevant to societal benefit. Realizing this objective, the industry and the college, named above, have signed this MOU in order to achieve the desired results for the benefit of the students and community.

OBJECTIVE OF MoU

- Offering classes to the students for their skill development in Advanced Carving Techniques.
- Encouraging involvement of student to take up projects of the industry and build up professional confidence and competence.
- Providing Training and Placement opportunity to the students.
- Providing Practical skills and Tests.
- To issue certificates to students who have been evaluated after the training.

TERMS AND AGREEMENT

1. Conducting practical classes, exam, evaluate and issue Government recognized Certificates.
2. Providing Training and placement for minimum 10% of the students.
3. This is a non-exclusive agreement and is valid for a period of one year, and may be extended further on mutual consent.
4. To provide necessary syllabus and study materials of industry standards to students.
5. All the Carving both perishable and non perishable materials will be provided by the industry for the students during the classes within the agreed fee amount.
6. Will organize certificate printing and award certificate in collaboration with both the parties involved.
7. For the services rendered by one party to other, the services charges, if applicable, shall be mutually agreed upon, and paid to the service provider.
8. The MOU can be terminated with three months notice on either side.
9. This agreement is governed by and construed in accordance with Indian Law.
10. The Head of Department concerned will be the coordinator for the interaction on behalf of the college and the industry will nominate a representative for the aforesaid.

11. "Advanced Diploma in Carving" will be provided for I B.Sc., Catering Science and Hotel Management students on consolidated fees of Rs 1,800/-(One Thousand Eight Hundred Only) per student for a duration of 30 days during the period of Dec 1st To Dec 30th from 2012-2015.

MODE OF PAYMENT FOR TRAINING PROGRAM

50 % of the course fees will be settled after the completion of the entire syllabus.

Remaining 50 % of the course fees will be settled after conducting exam, Post assessment distribution of certificates and offer letter for 10% of students.


The Add on fees will be shared by the parties in the ratio of 80% - **Thai Institute of Carving** and 20% - **Bharath College of science and management**.


Course Fee: Rs 1,800/- per Student.
